



EDGE turns 25

In its 25 years of operation EDGE has secured 5000 jobs across the Perth metropolitan area for 2000 people with intellectual, learning, physical, sensory, psychiatric and neurological disabilities. Three out of every four workers with disabilities supported by EDGE are employed in large corporations or public sector agencies.

EDGE invited its top 50 employers to a celebratory function at its Subiaco headquarters. EDGE Chairman, Mark Barnaba welcomed the assembled employers and introduced Richard Goyder CEO of Wesfarmers, which has employed 367 people with disability through EDGE since 1984.

Speaking on behalf of the employers, Mr Goyder said, "The partnership between Wesfarmers and EDGE has been mutually beneficial to both organisations and Wesfarmers is committed to extending the partnership across the group. I encourage other employers to follow suit".

EDGE Managing Director, Sue Robertson, thanked Mr Goyder and acknowledged the many hundreds of employers who had employed people with disabilities through EDGE over the past 25 years.

"Employment has a huge impact on the meaning and quality of life of everybody, including people with disability. EDGE is proud to have profoundly influenced the lives of so many people with disability who now proudly and productively take their place in the Western Australian workforce," Ms Robertson said.

Leading EDGE Award for CCIWA

A Leading EDGE Award was presented to the Chamber of Commerce and Industry (CCI) earlier this year for their commitment to helping people with disabilities enter the workforce.

CCI Chief Executive James Pearson said he was delighted to accept the award, which recognised their contribution as an employer of people with disabilities.

"We see the Leading EDGE award as an acknowledgement of what we are doing, on behalf of our members, to help Western Australian employers recognise that

"It was through DSC that I met Nathan and Sue from EDGE and developed a passionate interest in helping people within the disability sector," said Mr Rechner, who added that winning the award was totally unexpected.

Ron Gibson, who is widely regarded as one of Australia's foremost authorities in the field of business networking and relationship-building, is a long time advocate for people with disability.

"Receiving the award was a wonderful surprise which made me feel rather special, in that few companies these days make the effort to recognise their advocates, which makes this award very gratifying," Mr Gibson said.

EDGE Chairman, Mark Barnaba, presented Mr Rechner and Mr Gibson with their awards at a ceremony in May 2009.

"These individuals have set a great example to other businesses of the two-way benefits that can be gained by giving people with disability the opportunity to be part of the workforce," said Mr Barnaba.
